Campground and Lodge Reservation Policies
Adopted January 27, 2010

CAMPING RESERVATIONS/CANCELLATIONS

A. NIGHTLY/ MONTHLY CAMPING (A month is defined as thirty (30) consecutive nights for monthly rate calculation)

1. RESERVATIONS

Nightly and monthly reservations can be made **online only** at www.gogebicforestryandparks.com beginning the *second Monday in January* of each year. Only one reservation per date range/site occupant is permitted. Reservations must reflect the information of the occupant of each site or the reservation will be void. Residency credentials will be verified upon check-in.

- Reservations must be paid in full when created.
- Terms & Conditions must be accepted prior to occupancy.

2. CANCELLATION

Nightly/monthly reservations can be cancelled utilizing the link provided in the confirmation email. The Gogebic County Forestry and Parks Commission reserve the right to cancel any and or all reservations without cause. Gogebic County Forestry and Parks Commission will not refund any fees collected under those circumstances.

- Reservations cancelled more than one day in advance of arrival date will be refunded all prepaid fees EXCEPT (1) NIGHT.
- Reservations cancelled less than one day in advance of arrival date will be refunded all prepaid fees EXCEPT (2) NIGHTS.
- No-shows forfeit all prepaid fees. If not checked in by scheduled check-in time the day after scheduled arrival date, the reservation will be cancelled as a no-show.
- NO REFUNDS WILL BE CONSIDERED DUE TO EARLY DEPARTURES OR ACTS OF NATURE.

3. RESERVED CAMPSITE

If a campsite has been reserved and paid for, no other camper can occupy that site even if there is no camper in the site.

B. SEASONAL CAMPING:

(A seasonal camping site is defined as the period when the park opens until the park closes)

1. RESERVATIONS

Seasonal camping is not available at the Little Girl's Point Campground. Seasonal camping is available at the Lake Gogebic County Park, with the prior year seasonal camper offered the same campsite the following year. A letter with invoice will be sent to each seasonal camper in October of each year. Camper must remit 20% payment by the First Monday in November to retain their site for the upcoming camping season. Full payment is due by March 31st. When a seasonal site becomes available, it will be posted via website www.gogebicforestryandparks.com. Request for a seasonal site can only be made via phone call to the Gogebic County Forestry and Parks Office. Available seasonal sites will be filled in the order calls are received.

- Camper must remit 20% payment immediately upon receipt of invoice. Full payment is due by March 31st.
- Terms & Conditions must be accepted prior to occupancy.

2. CANCELLATION

Seasonal sites can be cancelled by contacting the Gogebic County Forestry and Parks Commission office. The Gogebic County Forestry and Parks Commission reserve the right to cancel any and or all reservations without cause. Gogebic County Forestry and Parks Commission will not refund any fees collected under those circumstances.

- Reservations cancelled more than 30 days in advance of arrival date will be refunded all prepaid fees EXCEPT \$100.
- Reservations cancelled less than 30 days in advance of arrival date will be refunded all prepaid fees EXCEPT 20%.
- No-shows forfeit all prepaid fees. If not checked in by scheduled check-in time the day after scheduled arrival date, the reservation will be cancelled as a no-show.
- NO REFUNDS WILL BE CONSIDERED DUE TO EARLY DEPARTURES OR ACTS OF NATURE.

3. RESERVED CAMPSITE

If a campsite has been reserved and paid for, no other camper can occupy that site even if there is no camper in the site

C. LODGE

1. RESERVATIONS

Nightly reservations can be obtained up to one (1) year in advance of occupancy online via website from end of May thru September. Friday through Sunday reservations from June thru September require a two (2) night minimum reservation.

- Renter must remit 50% payment at the time of reservation. Full payment along with damage deposit is due by May 1st.

2. CANCELLATION

Lodge reservations can be cancelled utilizing the link provided in the confirmation email . The Gogebic County Forestry and Parks Commission reserve the right to cancel any and or all reservations without cause. Gogebic County Forestry and Parks Commission will not refund any fees collected under those circumstances.

- Reservations cancelled more than 60 days in advance of arrival date will be refunded all prepaid fees EXCEPT \$200.
- Reservations cancelled less than 60 days in advance of arrival date will be refunded all prepaid fees EXCEPT (1) NIGHT.
- No-shows forfeit all prepaid fees. If not checked in by scheduled check-in time the day after scheduled arrival date, the reservation will be cancelled as a no-show.
- NO REFUNDS WILL BE CONSIDERED DUE TO EARLY DEPARTURES OR ACTS OF NATURE.
- RV sites will not be considered for refunds.

D. PAVILIONS

1. RESERVATIONS

Pavilions may be reserved for online (day use from 7 a.m. until 10 pm)

- Reservations must be paid in full when created.
- Terms & Conditions must be accepted prior to occupancy.

2. CANCELLATION

Pavilion reservations can be cancelled utilizing the link provided in the confirmation email.

- A refund equal to one half of rental will be issued upon cancellation of pavilion rental.
